What data are collected and how?

Volunteers are trained to walk predetermined routes on the beach and record observations on an MPA Watch datasheet.

Types of activities recorded include:

Onshore Activities

- Beach Recreation
- Tidepooling
- Shore-based Fishing

Offshore Activities

- Surfing
- Stand Up Paddle Boards
- SCUBA/Snorkeling

Boating

- Boat Fishing
- Kayaks
- Party Boats

Other Activities

- Potential Poaching
- Education
- Enforcement

Marine Protected Areas (MPAs)

Similar to state parks on land, Marine Protected Areas (MPAs) protect the diversity and abundance of marine life, the habitats they depend on, and the integrity of marine ecosystems by regulating the types of allowable take.

California is home to a network of 124 MPAs. There are 11 MPAs in San Diego County, which fall into three categories:



State Marine Reserve (SMR)

No take allowed.



No-Take State Marine Conservation Area (SMCA)

No take allowed.



State Marine Conservation Area (SMCA)

Limited take. Allowable take varies.

Volunteer Requirements

MPA Watch volunteers must:

- Be at least 15 years old or accompanied by an adult (under age 18 requires parental or guardian consent)
- Commit to completing at least two surveys a month for at least three months
- Be able to walk outside, on the beach, on uneven terrain
- Provide own transportation to/from surveys

New volunteers must complete a 60-90 minute training with a WILD COAST staff member. To schedule a training e-mail lisa@wildcoast.org.

Survey Sites

MPA Watch volunteers monitor 17 sites in:

- Encinitas
- La Jolla
- South La Jolla
- Imperial Beach

Surveys are completed along predetermined routes and range from 0.20 to 1.45 miles one direction. Once trained, volunteers may pick which site(s) they would like to survey.

Most sites are completed on foot; however, two driving sites exist in South La Jolla.
